Rules and Conditions

- 1. This programme is open to aspiring young first generation entrepreneurs.
- 2. Only one entry per individual will be considered. Entrants will complete a questionnaire designed to consider the following:
 - Does the individual have the potential to start and run a viable business?
 - Is his or her business idea viable?
 - Does he or she have some basic business skills?
 - Is the idea innovative?
 - Does the project have scope of scalability?
 - Does he or she have entrepreneurial skills to start an enterprise?
- 3. The application would be screened by the **Joint Screening Committee** on the basis of the above mentioned criteria and documents attached.
- 4. The final list of the qualifying candidates will be submitted to the **Joint Proposal Review Panel** (JPRP) of Experts and will be called for personal interview and presentation of business plan to be presented to JPRP. The date of the presentation will be intimated to the screened applicants. The Decision of the JSC and JPRP shall be final and is not subject to review.
- 5. In case a few candidates have a challenge to make a business plan or write a project report then they will be asked to attend a day's workshop on how to make a business plan and to make a project report.
 - Creating an effective business plan
 - Compiling a marketing plan
 - How to make a project report.
- 6. JPRP will identify the route for the entrepreneurs whether to be routed for Incubation or is ready for funding through financial institutions and accordingly the project will be routed.
- 7. Submissions must be completed in full, incomplete submissions shall not be accepted.
- 8. The concept/idea must be the entrant's own and original idea. Copying material, intellectual property or information from an external party or source will be considered plagiarism and the entrant will be disqualified. Disqualified entrants will forfeit any prizes awarded to them if any announced by the organizers.

No information will be used by the organizers and sponsors outside the ambit of this specific programme.
